# 7. Lingwood Post office / Coffee shop

Hosting a Coffee Shop during the day would be of interest to allow a 'drop-in' for the community.

Village hall coffee shop would run alongside the post office. Possibility even if the hall does not have the Post Office.

Press reported luncheon club at pub, this is the fortnightly coffee shop. Need to be careful with the EDP at the moment.
